Pleasant Valley Fire District Overview


- Pleasant Valley Fire District serves approximately 33.2 square miles. (32.9 square miles land; 0.3 square miles water)
 - Annexed area of service
- The district conducts fire, rescue and EMS response out of two fire stations:
 - Pleasant Valley Fire Station #1 located at 1619 Main Street Pleasant Valley (92% total yearly call volume).
 - Salt Point Fire Station #2 located at 30 Cottage Street, Salt Point (8% total yearly call volume)
- The District is a combination department with 4 career FF/EMT's, 8 Per-diem FF/EMT's and volunteer FF/EMT's. BLS crews.
- Career Staff consists of FF/EMT's through Fire tax.
 - Their set schedule shift is Monday Friday, 7:30am 3:30pm
 - The EMT's provide Basic Life Support (BLS) level of care and provide secondary "backfill" ambulance coverage
- Volunteer firefighters and/or EMT's (BLS)
 - 24/7/365 schedule, response as available
 - Nighttime 2 person duty crew staffing for ambulance coverage (BLS)
- Commercial ambulance service provides ALS/BLS coverage (Empress) through the town "Ambulance District Tax"
 - Monday-Sunday 5a-7p
- Fire, Rescue, EMS, ESS and Fire Police





A symbol of courage, dedication and community.





The Village of Pleasant Valley was incorporated on May 5th, 1814 and not long after the Village trustees set up a fire company. This is verified by a document appointing Jeremiah Clearwater as "a fireman in a company of firemen raised by authority of an act of the Legislature of the State of New York signed and sealed by William Thorn, President of the Pleasant Valley Village Trustees", dated August 18th, 1826.

Time marched on with no further mention of the Fire Company until 1903 when the John Knott Volunteer Fire Association appears as the agency created to respond to and handle all firefighting and emergency events in the village. Alfred Leith, Foreman, proposed that the Village accept the services of the fire company which the village did, in turn, accept. In 1907, the Village issued a proclamation (which can be found in a frame of Station # 1 Station # 1 meeting room) commending the John Knott organization for its dedication to protecting lives and property in Pleasant Valley and acknowledged them as the Pleasant Valley Volunteer Fire Company.





In 1946 there was a fatal house fire on Hibernia Road, across the street from the Helen Aldrich Park, in which a man by the name of Vincent Van Buskirk lost his life. The Pleasant Valley Fire Department responded to this fire and because of the distance of five miles for the fire company to come, the speed of the fire apparatus, together with the advance the fire had before the alarm was reported, the house was destroyed, and a man died.

The Salt Point Fire Company was formed June 16, 1947: "a number of the residents of Salt Point met in the old railroad station for the purpose of organizing a fire company. The meeting was called to order by Frank Bock. Cecil Sherow was appointed chairman."

On April 20th, 1948, the Salt Point Fire Company answered it's first call, which was a grass fire on Hibernia Rd.

Fire/Rescue




A firefighter is a trained professional responsible for combating and extinguishing fires to protect lives, property, and the environment. They respond to emergencies, perform rescues, and provide medical assistance when needed. Firefighters also engage in fire prevention, safety education, and community outreach. Their role requires physical endurance, bravery, and a commitment to public safety.

Rescue operations and special operations teams within fire departments specialize in responding to complex emergencies beyond traditional firefighting. These teams are trained to handle situations such as technical rescues, hazardous material incidents, and urban search and rescue missions. PVFD currently has an ice rescue team, a developing Rescue Task Force Team (RTF) for warm and cold zone operations and members trained in specialized auto-extrication.

Emergency Medical Services (EMS)

Emergency Medical Services (EMS) are a critical component of public health and safety, providing rapid medical response and care during emergencies. EMS professionals, including Emergency Medical Technicians (EMTs), are often the first on the scene when accidents, injuries, or sudden illnesses occur. They are trained to assess the situation quickly, administer life-saving treatments, stabilize patients, and transport to medical facilities. The work of EMS personnel is crucial in ensuring timely medical intervention, which can significantly improve outcomes for those in critical need.


Membership Process



- Your application needs to be filled out completely and accurately.
- Submit the completed New Member Application in person at PVFD Sta 1
- Following review of your application during respective fire company monthly meeting, you will be contacted by a member of the Pleasant Valley Fire District Membership Committee to set up your interview.
 Under 18 applicants must be accompanied by a parent or legal guardian.
- Your interview will be conducted with the interview committee on scheduled date and location, lasting approximately 20 mins.
- The District will perform a New York State Arson Check, Sex Offender and due diligence regarding your background.
- You will then schedule an appointment with PVFD Medical Provider for a full physical exam paid for by PVFD. **Under 18 applicants must be accompanied by a parent or legal guardian**
- Your membership application goes before the respective fire company at the next monthly meeting following your interview. The Fire Company votes on your application.
- If the Fire Company membership accepts your application, your membership application goes before the Pleasant Valley Board of Fire Commissioners (BOFC) at their next monthly meeting. Final acceptance of membership is subject to approval by the BOFC.
- The PVFD District Secretary will mail an acceptance letter to you providing additional instructions.

Restricted Age

- Any person who is between the ages of 16 and 18, who is physically fit, morally and mentally sound, and who, having met with the membership committee and satisfactorily passed the committee's investigation (as established in the Pleasant Valley Fire District), may be selected for membership status.
- The goal of this program is to carefully instill, enforce and monitor the practices that lead to well trained, respectful, hardworking members once they reach their 18th birthdays.



- A Chief and a training officer act as a resource to these members in all aspects of PVFD membership: firefighting, training, rules and regulations, etc. – and set example for the types of behaviors expected from our entire membership.
- Applicants **MUST** have their parents or legal guardians:
 - sign their application
 - consent and attend the Fire District physical
 - attend the interview
 - sign Restricted Age Policy acknowledging age limitations to participate in any and all activities of the department.
- Under-18 Restricted Age Members must follow specific rules established by the Pleasant Valley Fire District.

Health Risks

Volunteering in emergency services like firefighting and emergency medical services (EMS) exposes volunteers to various health risks. These include exposure to hazardous chemicals, such smoke. materials as and biological contaminants, which can lead to respiratory issues and longterm health problems. Additionally, physical exertion during emergencies can strain muscles and joints, leading to injuries. Psychological stress from witnessing traumatic events and managing high-pressure situations can also impact mental health. Furthermore, frequent exposure to loud sirens and equipment noise may contribute to hearing loss over time. Proper training, use of personal protective equipment (PPE), and ongoing health monitoring are essential to mitigate these risks and ensure the well-being of volunteer firefighters and EMS personnel.

The PVFD Board of Fire Commissioners and Chief Staff are deeply committed to ensuring the personal safety and mental well-being of all our volunteers. They prioritize providing a supportive environment that includes access to resources for mental health support, counseling services, and peer assistance programs. By fostering a culture that values the physical and emotional health of volunteers, PVFD aims to enhance resilience and ensure that every member feels supported in their crucial role within the community.
